SELLER'S RECEIPT AND CONTRACT

This form, when signed by you as Seller and on behalf of Circle Art Agency, will constitute a contract under which Circle Art Agency, as your agent, is authorised and undertakes to sell your artwork(s) listed below, subject to Circle Art Agency's Conditions of Business. You should read these Conditions and ask any questions you may have about them before signing this form.

The charges payable to Circle Art Agency by the Seller per lot sold are: 25% commission on the hammer price plus 16% VAT thereon.

Other charges that may be deducted from the sale proceeds include (but are not limited to) such things as framing/stretching/repair of artwork, import duties, shipping costs, bank charges and artist resale rights (only due if the artist is Kenyan - at 5% of the net hammer price). Circle Art Agency will advise you of such costs prior to payment of the sale proceeds.

Purchase of secondary market Kenyan art, marked ARR (Artist Resale Royalty) will be subject to payment of an Artist Resale Royalty as required by the Kenyan Copyright (Amendment) Act 2019. The amount payable will be calculated at a rate of five percent (5%) on the net hammer price. The net Hammer price would be the hammer price minus agency commission. The AAR applies to lots sold for KES 20,000 and above and does not apply to lots sold for charitable purposes and will be payable by the seller. Circle Art Agency will retain this 5%, pay the artist or artist's estate and keep a record of payment.

Circle Art Agency will insure, for the agreed reserve price, all artwork once it is in our care. The consignment period will be for a maximum of three (3) months. If the artwork doesn't sell at the auction we will attempt to sell it afterwards; if not, arrangements will be made to return the work to the Seller.
